


VpCI®-390

VpCl[®]-390 is a waterborne, temporary coating that is intended for medium to long term outdoor protection. Once cured, it provides a non-tacky film that has excellent salt, humidity, and UV resistance.

EcoLine[™] Cleaner/Degreaser or Cortec[®] VpCl[®]-433 can be used to remove VpCl[®]-390 if necessary. VpCl[®]-390 is also available in a black version.
