PRODUCT DESCRIPTION

VCI-644 is an additive that protects ferrous and nonferrous metals from corrosion induced by waters containing inorganic salts, including chlorides. A concentrated formulation, VCI-644 offers low dosage effectiveness as a treatment for a wide variety of marine and process applications requiring economical corrosion inhibition for fresh water, salt water and brine solutions. VCI-644 contains organic ingredients and has strong film persistency abilities. VCI-644 is effective as a replacement for hydrazine-based formulations or formulations containing nitrites, phosphates, chromates or other heavy metals.

VCI-644 does not contain nitrites, phosphates, hydrazine, chromates or other heavy metals.

FEATURES

- Prevents corrosion from fresh and salt water, brine, chloride and other dissolved halogens of ferrous and non-ferrous metals.
- Nitrite/chromate/zinc/phosphate-free.
- Low concentration effectiveness provides economical treatment.
- Residual protection after hydrotest solution is drained out is 1 to 2 months.
- Effective in temperatures up to 200°F (98°C) in liquid and vapor phases.

TYPICAL APPLICATIONS

Cooling/Heating Systems: Add VCI-644 at a concentration level of 0.1-0.25% by weight to brine, containing 3-5% of chlorides and other aggressive inorganic salts. Protection in liquid and vapor phases is greater than 95%.

Hydrotesting with Sea Water:

VCI-644 provides protection greater than 95% when added at a concentration level of 0.05-0.10% by weight.
